(hereinafter referred to as the "Release Agreement") BY SIGNING THIS DOCUMENT YOU WILL WAIVE OR GIVE UP CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE OR CLAIM COMPENSATION FOLLOWING AN ACCIDENT. <u>PLEASE READ CAREFULLY!</u>
I, the undersigned, am aware that my participation in physical training, exercise activities and athletics (hereinafter collectively referred to as the "ACTIVITIES" whether or not the Activities occur within the Squamish Barbell Lifting Company Inc. gym, or on any other public or private property including, but not limite to, roads, and sidewalks, private driveways and parking lots, trails and loose or uneven surfaces, involve many risks, dangers, and hazards INCLUDING BUT NO LIMITED TO: SERIOUS BODILY INJURY; PERMANENT DISABILITY; PARALYSIS; DEATH; INJURY, SICKNESS, DISEASE, DEATH, OR ANY EXPENSE, DIRECTL OR INDIRECTLY ORIGINATING FROM, CAUSED BY, ARISING OUT OF, CONTRIBUTED TO BY, RESULTING FROM, OR OTHERWISE IN CONNECTION WITH, A COMMUNICABLE DISEASE, INCLUDING BUT NOT LIMITED TO COVID-19, OR THE FEAR OR THREAT (WHETHER ACTUAL OR PERCEIVED) OF A COMMUNICABLE DISEASE, INCLUDING BUT NOT LIMITED TO COVID-19 (the "Risks"); NEGLIGENCE ON THE PART OF SQUAMISH BARBELL LIFTING COMPANY INC., A.K.A. SQUAMISH BARBELL, CROSSFIT SQUAMISH, THE ORGANIZERS, ITS PRINCIPLES, DIRECTORS, OFFICERS, EMPLOYEES, AGENTS REPRESENTATIVES, VOLUNTEERS, SPONSORS, OWNERS, SUCCESSORS and ASSIGNS (hereinafter collectively referred to as "SQUAMISH BARBELL"). I understand that my participation in the Activities involves an increased risk of injury to me. I freely accept and willingly assume full responsibility for all such risks, dangers and hazards, including but not limited to the possibility of personal injury, death, property damage or loss resulting from the ACTIVITIES whil at, or under the direction of, SQUAMISH BARBELL.
INITIAL:
I agree to self-limit my exertion through my own good judgment and to terminate any physical activity immediately if it exceeds my personal limitations, whether or not it exceeds the activity level recommended by the staff or prescribed by my physician. If my current fitness/injury status limits my participation in the ACTIVITIES, I understand and assume the risk of injury or other adverse health consequences, including but not limited to grievous bodily harm and or deatly if I exceed the exercise and dietary guidelines recommended by my consulting physicians. I agree that my non-compliance may result in termination of mentitlement to train at SQUAMISH BARBELL. I also hereby consent to and permit emergency treatment in the event of any injury or illness.

This Release Agreement and any rights, duties and obligations as between the parties to this Release Agreement shall be governed by and interpreted solely in accordance with the laws of the Province of British Columbia and no other jurisdiction and any litigation involving the parties to this Release Agreement shall be brought solely within the Province of British Columbia and shall be within the exclusive jurisdiction of the Courts of the Province of British Columbia.
